
FABULOUS GREECE THE CORINTH CANAL AND THE METEORA (PORT-TO-PORT CRUISE)

DAY 1 ATHENS

Passengers are welcome to board our ship at 6:00 p.m. We'll introduce our crew at a welcome cocktail before dinner on board. Tonight's meal and entertainment will have a genuine Grecian flair!

DAY 2 Athens - Passage through the Corinth Canal

This morning, the excursion proposed is: Athens and the Acropolis. Although it has been destroyed and rebuilt many times, today's restored and preserved Acropolis ruins stir our imaginations as to the former splendor of famous buildings such as the Parthenon, Propylaea, Erechtheion, and the Temple of Athena Nike. We'll spend the afternoon cruising and pass through the Corinth Canal. The canal is 4 miles long (6.4 km) and 70 feet wide (24.6 m) at its base, making it impassable for most modern ships. We'll arrive in Corinth at the end of the afternoon. Our ship will remain in port overnight.

DAY 3 CORINTH

We'll spend the morning on an excursion through the region of Argolis to visit Mycenae and Nafplio. We'll first explore Mycenae. According to Greek mythology, Perseus founded Mycenae and used Cyclopes to build the citadel walls. Next, we'll continue on to Nafplio—the first capital of modern Greece, dominated by Palamidi Fortress. We'll begin our cruise to Itea this afternoon.

DAY 4 ITEA

Join us for an excursion to Delphi this morning. Although the Sanctuary of Apollo is arguably one of the most important historical sites in Greece, only the monumental pedestals remain today as silent witnesses to a lost grandeur. We'll begin our cruise to Patras this afternoon.

DAY 5 PATRAS

In the morning, we'll set out on a tour of Olympia. The impressive ruins in Olympia include the Ancient Stadium and the temples of Zeus and Hera. We'll begin our cruise to Igoumenitsa this afternoon. This

would be a great time to hit the Sun Deck to catch some rays! Our ship will cruise through the night.

DAY 6 **IGOUMENITSA**

Join us for a full-day excursion to the Meteora (approximately 5 hours of round-trip travel – lunch is included). Discover one of the most spectacular sites in Greece. Although the original town of Kalambaka was destroyed during World War II, the Meteora monasteries remained intact on the summit of the rocks. We'll begin to cruise to Durrës.

DAY 7 **DURRES**

We'll spend the morning cruising. In the afternoon, we'll visit Tirana. We'll see Skanderbeg Square, the city center surrounded by important government buildings, as well as the historic Et'hem Bey Mosque. Tonight is our festive gala evening. Our ship will cruise to Dubrovnik overnight.

DAY 8 **DUBROVNIK**

Enjoy one last buffet breakfast on board before disembarking at 9:00 a.m. End of our services.
