DAY 1 ATHENS

Passengers are welcome to board our ship at 6:00 p.m. We'll introduce our crew at a welcome cocktail before dinner on board. The rest of the evening is yours to do as you please.

DAY 2 ATHENS

In the morning, join us for the optional excursions proposed: **CLASSIC:** Athens and the Acropolis. Sites we will see include the Parthenon, Propylaea, Erechtheion, and the Temple of Athena Nike. **DISCOVERY:** heavenly Kaisariani Monastery. This afternoon, join us for an optional excursion to Cape Sounion. We'll visit the ruins of the Temple of Poseidon, dating back to the Golden Age of Athens. Our ship will cruise through the night.

DAY 3 DELOS - MYKONOS

This morning, join us on an optional excursion to Delos, the mythical birthplace of Apollo (travel to and from the island will be done in rowboats). We'll visit the sanctuary dedicated to Apollo, the Terrace of the Lions, and the Theater Quarter. Our ship will cruise to Mykonos. This afternoon, join us for the optional excursions proposed: **CLASSIC:** Mykonos. We'll tour Mykonos Town and the Monastery of Panagia Tourliani. **DISCOVERY:** catch some rays at one of the most beautiful beaches on the island (sunlounger and umbrella rental included). Greek cocktails and traditional entertainment on board. Our ship will cruise to the Dodecanese overnight.

DAY 4 KOS

We'll spend the morning cruising. This afternoon, join us for an optional excursion to Kos and the Asklepion. An Asklepion was the ancient Greek version of med school, where healers cured patients and taught others their techniques. We'll also visit several sites in the city of Kos. Our ship will cruise to Rhodes overnight.

DAY 5 RHODES

This morning, join us on an optional excursion to medieval Rhodes. Visit the old town and the medieval castle. This afternoon, join us for the optional excursions proposed: CLASSIC: Lindos, charming fishing village. DISCOVERY: Kick back at Tsambika Beach (sunlounger and umbrella rental included). Our ship will cruise through the night.

DAY 6 SANTORINI

We'll spend the morning cruising the Aegean Sea. This afternoon, join us for an optional excursion to the legendary island of Santorini (travel to and from the island will be done in rowboats).
