DAY 1 CHALON-SUR-SAÔNE

Passengers are welcome to board our ship at 5:00 p.m. After comfortably settling into your cabins, we'll introduce our crew at a welcome cocktail.

DAY 2 MÂCON, BEAUJOLAIS VINEYARDS - LYON
