DAY 1 MARTIGUES(1) - BOARD SHIP

Passengers are welcome to board our ship in Martigues at 6:00 p.m. After comfortably settling into your cabins, we'll introduce our crew at a welcome cocktail.

DAY 2 PORT SAINT LOUIS - ARLES - AVIGNON

We'll cruise towards Port-Saint-Louis. Join us for the optional excursions proposed: **CLASSIC:** Discover the Camargue. We'll visit a "manade" (horse breeding farm) and learn about how a manadier works with the animals. **DISCOVERY:** Safari in jeeps through the Camargue for an original immersion in the wilderness. This afternoon, join us for the optional excursions proposed: **CLASSIC:** Guided tour of Arles, a highly cultural town enriched with vestiges from the Roman Empire. **DISCOVERY:** Hike in the Alpilles Mountains to the village of Baux-de-Provence. We'll cruise to Avignon.

DAY 3 AVIGNON - VIVIERS

Join us on an optional excursion for both packages: Guided tour of Avignon and the Papal Palace. The afternoon will be spent cruising to Viviers. Join us on an optional excursion for both packages: Guided tour on foot of the city.

DAY 4 VIVIERS - TAIN L'HERMITAGE

Join us on an optional excursion for both packages: Tour of the Ardèche Gorges. We'll return to the ship in La Voulte. In the afternoon, join us on an optional excursion for both packages: Discover the Vercors and taste the famous Clairette de Die*. We'll return on board in Tain-l'Hermitage.

DAY 5 TAIN L'HERMITAGE - VIENNE - LYON

We'll cruise towards Vienne this morning. We'll begin to cruise early in the morning towards Tournus. Join us on an optional excursion for both packages: Visit the famous Hospices de Beaune, whose facade is today regarded as a superior example of Northern

Renaissance civic architecture. We'll continue along the Burgundy Wine Route and through villages with names that evoke the great French wines. We'll then return on board in Chalon-sur-Saône at the end of the afternoon. Tonight is our gala dinner and evening.

DAY 7 CHALON-SUR-SAONE DEPARTURE

Enjoy one last buffet breakfast on board before disembarking at 9:00 a.m. End of our services.

We therefore do not warrant the performance of any service provider.
