## **DISCOVER LISBON, PORTO AND THE DOURO VALLEY (PORT-TO-PORT CRUISE)**

### **DAY 1 LISBON**

Afterwards, we'll return to our hotel. The evening is free to do as you please.

### **DAY 3 LISBON - COIMBRA - PORTO**

Departure by coach to Coimbra, a romantic source of inspiration to many a poet. This afternoon, we'll discover this charming city that cascades down the hillside to the Rio Mondego. After our tour, we'll hit the road again towards Porto. Passengers are welcome to board our ship at 5:00 p.m. After comfortably settling into your cabins, we'll introduce our crew at a welcome cocktail. In the evening, join us on an optional excursion by coach for both packages: Tour of Porto by night.

### **DAY 4 PORTO - REGUA**

This morning will be spent cruising. Join us on an optional excursion for both packages: Guided tour of Lamego. Enjoy an evening of dancing.

### **DAY 5 REGUA - PINHAO - PORTO ANTIGO**

### **DAY 7 PORTO - GUIMARÃES - PORTO**

Enjoy time at leisure this morning to discover Porto at your own pace. This afternoon, join us for the optional excursions proposed : CLASSIC: Tour of Guimarães. DISCOVERY: Hiking to Vila Nova de Gaia and tasting of some of the local wines\*. Tonight's our gala evening and dinner followed by traditional folk entertainment.

If we or our service providers are affected in any way by a force majeure event, we may in our discretion vary or cancel any itinerary or arrangement in relation to the tour as we consider necessary, without incurring any liability to you.

Each service provider is responsible for the part of the tour it conducts. Service providers are not our agents or employees and are not under our direct control. We therefore do not warrant the performance of any service provider. We do not accept, and you release us from, all liability for any injury, loss, damage, costs or expenses, including without limitation any property damage or personal injury, that you may suffer which arises out of any act or omission of a service provider or operator who provides services in connection with your tour. Any claim that you may have in relation to a service provider should be raised directly with that service provider.

You are responsible for any injury, loss, damage, costs or expenses arising through your own fault. You

agree to indemnify us against all actions, proceedings, claims, demands, expenses and costs (including legal costs on a full indemnity basis and whether incurred by or awarded against us) as a result of, or arising in relation to, whether directly or indirectly, your participation in the tour or any act or omission by you in relation to the tour. To the extent permitted by law, we do not accept any liability in contract, or otherwise for any injury, damage, loss (including consequential loss), delay, additional expenses or inconvenience caused directly or indirectly by the acts, omissions or default, whether negligent or otherwise, of third party providers over which we have no direct control.

Under circumstances where our liability cannot be excluded and where liability may be lawfully limited, such liability is limited to the remedies required of us under applicable law (including the Australian Consumer Law). This liability clause is subject to your rights under the Australian Consumer Law and nothing in these terms and conditions is intended to limit any rights you may have under the Competition and Consumer Act 2010 (Cth).
