DAY 1 STRASBOURG - PRAGUE ARRIVAL

Departure by coach from Strasbourg (mooring port - rue du Havre). Free lunch on the way. Arrival in the end of the afternoon in Prague (or surroundings). Check into your hotel 3* NL in Prague or the surrounding area. Dinner. Free evening.

DAY 2 PRAGUE GUIDED TOUR
