DAY 1 STRASBOURG - BOARD SHIP

Passengers are welcome to board our ship at 6:00 p.m. We'll cruise to Mainz. After comfortably settling into your cabins, we'll introduce our crew at a welcome cocktail. Tonight we'll enjoy dinner and an evening of entertainment. Our ship will cruise through the night.

DAY 2 MAINZ - KOBLENZ

Join us for the optional excursions proposed: **CLASSIC:** Guided tour of Mainz and the Gutenberg Museum. **DISCOVERY:** Touring the Rhineland vineyards. We'll spend the afternoon cruising along the most beautiful section of the romantic Rhine. Once we arrive in Koblenz in the evening, we'll set out on a discovery tour of the city with our hostess.

DAY 3 KOBLENZ - COCHEM - TRIER

Versailles. (On Mondays, this visit is replaced by the Château de Malmaison). We'll then return on board and depart for Vernon.

DAY 7 VERNON - ROUEN - HONFLEUR

In the morning, we'll cruise past Les Andelys and Amfreville before reaching Rouen. In the afternoon, join us on an optional excursion for both packages: Guided tour of the city. We'll then return on board and depart for Honfleur. Tonight is our gala dinner and evening.

DAY 8 HONFLEUR

Join us this morning on an optional excursion for both packages: Guided tour of Honfleur. This afternoon, join us on an optional excursion for both packages: Discover the Côte Fleurie, including the famous seaside resorts of Trouville and Deauville.

DAY 9 HONFLEUR DEPARTURE

Enjoy one last buffet breakfast on board before disembarking at 9:00 a.m. End of our services.
