DAY 1 TOKAJ

Passengers are welcome to board our ship at 6:00 p.m. After comfortably settling into your cabins, we'll introduce our crew at a welcome cocktail. The evening is free to do as you please.

DAY 2 TOKAJ - TISZAFURED

Afterwards, we'll begin to cruise along the lakes and rivers through the Great Southern Plain. Enjoy a Hungarian feast this evening. We will reach Tiszafured marina in the morning.

DAY 3 TISZAFURED - CSONGRAD

Join us for an optional excursion to Hortobagy, called "the Puszta". We'll arrive in Csongrád during the evening. Enjoy an evening of onboard entertainment.

DAY 4 CSONGRAD - CSANYTELEK - SZEGED
